**EXCUSAL and RESCHEDULING:** Any request to be rescheduled or to be exempted from jury service must be submitted within 5 days of receipt of this summons. No person may be excused from jury service without submitting proper documentation to the court.

**RESTRICTIONS:** Everyone entering the Courthouse must go through security screening. Purses and packages will be x-rayed. You may be searched. Do not bring any weapons, dangerous objects or explosives into the building. Jurors must dress appropriately. Business casual is preferred.
